From the South (680 North)

Take 680 North toward Concord
Take Concord/Burnett Avenue Exit
Turn left on Diamond Boulevard
Turn right on Concord Avenue
Go past Concord Airport/Sam's Club/Sports Authority
Turn left at light on Stanwell Drive
Turn right on Bisso Lane
Take the first left on Bisso, into our Parking Lot
Take the stairs to the second floor on the east end of the building, or the elevator on the west end

From the East (CA-4 West - 242 South)

Take CA-4 West toward Concord
Merge onto 242 South
Take Concord Avenue Exit
Turn right at the end of the exit ramp at the traffic light
Turn on right Stanwell Drive
Turn right on Bisso Lane
Take the first left on Bisso, into our Parking Lot
Take the stairs to the second floor on the east end of the building, or the elevator on the west end

From the West (CA-4 East)

Take CA-4 East toward Concord
Merge onto 242 South toward Oakland/Concord
Take Concord Avenue Exit
Turn right at the end of the exit ramp at the traffic light
Turn on right Stanwell Drive
Turn right on Bisso Lane
Take the first left on Bisso, into our Parking Lot
Take the stairs to the second floor on the east end of the building, or the elevator on the west end

From the West (CA-4 East)

Take CA-4 East towards Pittsburg/Antioch
Continue on CA-4 Bypass East
Make a left onto Balfour Road
Make a right on Guthrie Lane
The district office is on the right
