## ACADEMIC REINSTATEMENT GUIDELINES

- Each student will be allowed **ONE** Academic Reinstatement during grades 10-12

*Note:* Students will also be allowed one Academic Reinstatement during their freshman year, however it is a “use it or lose it” proposition. Not using during the freshman year, does not afford the student the ability to use it at a later date.

- All applicants for Academic Reinstatement will be reviewed by the Athletics Department, and Principal.
- Eligibility goes into effect the Monday following the posting grades or in the fall term on a date determined by the Athletic Coordinator. (Dates of Determination are set July 15<sup>th</sup> each year)
- All applicants for Academic Reinstatement shall be made during the five school days immediately following the posting of grades, and the first five days of school in the following academic term if they are ineligible at the end of the previous school year.
- Quarter grades will be used as a criteria for determining eligibility at the end of quarters one and three, and semester grades will be used as a criteria at the completion of the second and fourth quarters.
- Students that must file for Academic Reinstatement will not be allowed to participate in athletic competition during the duration of the filing period.
- Incomplete applications must be corrected before application is considered. (This includes applications without signatures).
- Eligibility will be determined by the panel within 1 school day from the application closing period.

## CRITERIA FOR APPLICATION

- Any student that applies for Academic Reinstatement (below 2.0) must meet the following criteria:
  - Have a minimum GPA of 1.5 or higher (below a 2.0)
  - Have successfully passed a minimum of four classes and have no more than 2 F’s in their core curriculum (periods 1 – 6, not including 0, or 7<sup>th</sup> period).

## MAINTAINING ELIGIBILITY WHILE ON RE-INSTATEMENT

- As part of the Academic Reinstatement Guidelines, Student Athletes who choose to use Reinstatement must:
  - Complete a minimum of three hours of study hall/mastery center each week.
  - Complete a weekly Progress Report and submit to the Athletics Office each week.
- Students that accumulate ten or more tardies during their term of Academic Reinstatement will have their eligibility rescinded (this will count as a used re-instatement)\*
- Students that accumulate five or more unexcused period absences during their term of Academic Reinstatement will also have their eligibility rescinded (this will also count as a used re-instatement)\*

\*To be reviewed weekly by Athletic Coordinator and Principal.
